PROSPECTUS LODGED FOR ENTITLEMENTS ISSUE

Apollo Minerals Ltd (ASX: AON) (“Apollo” or “the Company”) is pleased to advise that a Prospectus in respect to the Company’s one for one non-renounceable entitlements issue (“Offer”) was lodged with ASIC today.

On 11 May 2016, the Company announced that it would undertake the Offer which will now raise up to \$3.1 million before costs. Under the Offer, eligible shareholders will be entitled to acquire one (1) new ordinary share (“New Shares”) for every one (1) ordinary shares held at the record date (being 28 July 2016) at an issue price of \$0.05 per New Share.

The Prospectus together with an Entitlement and Acceptance Form are expected to be sent to eligible shareholders on 29 July 2016.
